Ike,

Per our conversation, the BLM will approve the removal of the 2,990 mg/kg in AH-1, the 11,900 mg/kg in AH-2, and 4' of material in AH-3. AH-1 and AH-2 can be backfilled with caliche from downsizing location, etc. AH-3, you can utilize the same caliche for 3' of backfill followed by utilizing topsoil from the outside edges of the remediation site, or from location stockpiled topsoil. Seed with BLM #2 seed mix. Notify BLM prior to backfill. Thanks
