Ms. Gladden,

The OCD has denied the submitted Closure Request C-141 for incident # NRH2003443103 for the following reasons:

- I have several questions and comments about the sampling events and the sample data provided in the closure report.
 - Were the delineation samples also to be considered confirmation samples? If so, an email notification 48-hours prior to the sample event should have been sent to NMOCD and needs to be included in this report.
 - Were the preliminary confirmation samples collected as actual confirmation samples?
 - The lab report for the January 17th and 18th, 2020 sampling event needs to be included in this closure report.
 - At what depths were the samples collected for samples listed in the last 3 tables of this closure report (pages 5 and 21 of this submittal)
 - At what locations were the preliminary closure samples and the closure samples collected (last two tables on page 5)? The map included in the report appears to show only the delineation samples.
 - For the samples labeled "COMP MIX" and "SW 1-4" at depths A/B, are the COMP MIX

samples composites of SW 1 – 4, and the SW samples are point samples? Unless previously approved by the division, sampling must adhere to 19.15.29.12 D. (1)

- Samples COMP MIX (Depth B) and SW 4 (Depth B) exceed 100 mg/kg TPH.

The Denied C-141 can be found in the online image file. Please review and make the required corrections prior to resubmitting through the fee portal. If you have any questions or believe this denial is in error, please contact me prior to submitting an additional C-141.
