XTO is requesting an extension of the 90 day deadline of June 30, 2019 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Palmillo State #001H (2RP-5389). The release was discovered April 1, 2019. XTO initiated site characterization the same day. The release occurred in the pasture along the Palmillo flowline on state land. A Right of Entry (ROE) Permit was submitted to the State Land Office (SLO) on May 24, 2019. Approval of the ROE permit and an arch survey of the site are still pending. XTO has sent regular reminders to the SLO to facilitate timely approval. Due to the pending approval, XTO requests an extension of this deadline until September 30<sup>o</sup> 2019.
