XTO is requesting an extension to the current deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Big Eddy Unit 150. A release was discovered on August 19, 2020 that was assigned incident number NRM2024854885. An extension for this release was previously granted by NMOCD with a current due date of February 15, 2021 due to upcoming Plugging and Abandonment (P&A) activities that would interfere with the remediation project at the Site. XTO requested to complete remediation upon completion of the P&A. P&A activities have recently been completed and remediation activities are scheduled to commence. To provide enough time for further site assessment, delineation, remediation work and the completion of a remediation work plan or closure report, XTO requests an extension of the deadline to **May 16, 2021**.
