On August 23, 2019 completions reported a spill due to the actuator on the tub inlet valve failing. Fresh water continued into the tub causing the water to spray out. A total of 113 bbls of frac fluid was released (49 bbls was released onto the engineered pad and 64 bbls was released inside the secondary containment for the tub). Vacuum trucks were already on site and were able to recover 100 bbls total (inside secondary containment and from the engineered pad). Sorry about the late notification, we were just notified of this release. An initial C-141 will follow soon.
