01/29/01: Spud @ 6:00 PM, 01/28/01. Drill 11" surface hole to 330'. Run 16 jts. of 8-5/8" 23 ppf to 324'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 6 bbls cement to surface. WOC 8 hrs.

01/30/01: Test surface csg to 500 psi for 30 minutes. Drill 7 7/8" hole from 330'-2415'. RU Schlumberger & log.

01/31/01: MIRU Leed. Run 57 jts. of 5 1/2", 15.5 ppf to 2369'. MIRU Halliburton. Mix and pump 20 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 338 sx 12.5 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite TR 1/4, 5 lb/sx Gilsonite, 0.3% Versaset & 0.3% Super CBL. Plug down @ 12:39 PM 01/30/01 with 1250 psi. Circulated 8 bbls cement to surface.

02/13/01: MIRU Patterson Wireline. Ran Sector Bond Log from surface to 2354'. Top of Cement @ surface.
