04/02/02 Spud in @ 7:30 a.m. Drill 11" surface hole to 325'. Ran 10 jts of 8 5/8", J-55, 23 ppf ST&C casing to 323'. Halliburton mixed and pumped 85 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 50 psi with 6% salt, 5#/sx gilsonite, .3% versaset. Circulated 3 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

04/03/02 Drill 7 7/8" hole f/ 325' - 2305'. Reached TD 2308' at 4:30 a.m. MIRU Schlumberger & log well. Ran 55 jts of 5 1/2", M-50, 15.5 ppf LT & C casing to 2251'. Halliburton mixed and pump 20 bbls gel pre flush at 4 bpm at 25 psi, 290 sks Midcon II, 13.0 ppg, yield 2.04, with 6% salt, .3% versaset, 5#/sx gilsonite, and .3% Super CBL. Plug down @ 2:08 p.m. with 1860 psi. Circulated 10 bbls of cement to surface. Well shut in.
