17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded well at 9:00 AM on July 22, 1980. Drilled 11" hole to 20' TD. Ran 20' of 8 5/8" 32# casing and cemented with 7 sacks of neat cement from TD to surface. Drilled 7 7/8" hole to 825' TD. Received permission to plug well from Mr. R. L. Stamets March 2, 1981. His instructions were to set a 65 sack cement plug from 825' TD back to 600' and a 15 sack cement plug from 40' to surface. Ran drill pipe to 800' and set a 70 sack cement plug from 825' TD back to 580'. Ran a 7 sack cement plug from 40' to surface. Finished cementing operations March 8, 1981. Installed steel marker and covered pit. Location is ready for inspection.
