On 4-6-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 9:30 p. m. Drilled to a TD of 703' and ran 8-5/8" casing set at 703'. Cemented with 500 SX Class H cement. Plugged down 11:00 p.m. 4-7-81. Circulated 142 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2170' and ran 5-1/2" casing set at 2137'. Cemented with 630 SX Class H cement. Plugged down 4:45 a.m. 4-12-81. Circulated 150 SX. Currently waiting on completion unit.
