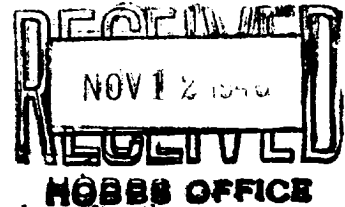

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well casing was tested by Halliburton Oil Well Cementing Company and found leaks at 420 ft. and 720 ft. 600 sacks cement were pumped by Halliburton and leaks plugged. Test showed job is satisfactory. Also, 216'-7" of 7" O.D. liner was set on bottom (2102 ft) to hold small cavings at bottom
