INSTRUCTIONS
IN THE FILING OF FORMS FOR THE DRILLING OF OIL WELLS
AND PLUGGING OF DRY HOLES IN THE STATE OF NEW MEXICO

1. A plugging bond in the proper amount, must be filed with - and approved by - the Oil Conservation Commission; P. O. Box 2088, Santa Fe, New Mexico, 87501.

2. The following forms must be filed with the appropriate district office of the Commission:

Form C-101, Notice of Intention to Drill, 5 copies for patented land and 6 copies for state land.

Form C-102, Well Location Plat, 3 copies for all locations must accompany Form C-101.

→ Form C-103, Sundry Notices and Reports on Wells, 3 copies for each string of casing, reporting spudding date and the results of test of casing shutoff, etc. must be filed within 10 days after test.

If the well is completed as a producer, the following forms must be filed:

Form C-104, Request for Allowable and Authorization to Transport Oil and Natural Gas. The initial allowable will be assigned effective on the date of completion, provided this form is filed during the month of completion. Otherwise, it will be effective on the first day of the month in which the form is filed. This form must be accompanied by a notarized, tabulated list of all deviation tests taken on the well. This form will not be approved until all the above listed forms have been filed, no allowable may be assigned the well.

→ Form C-105, Well Record, 4 copies for patented land and 5 copies for state land, with one copy of all electrical and radio-activity logs run on the well, must be filed within twenty days after completion.

Form C-116, Gas Oil Ratio Report, 2 copies must be filed, reporting a gas oil ratio test taken between the 20th and 30th day after completion for all wildcats and all wells in pools that are not exempt from the tests.

If the drilling operations result in a dry hole, the following procedure must be followed:

Permission must be received prior to plugging wells.

→ Form C-103, Sundry Notices and Reports on Wells, 3 copies must be filed, outlining the proposed plugging operation, including length and depth of plugs, plans for mudding, cementing, shooting, testing, and removing casing, and the date of the proposed plugging operation. Oral permission may be obtained by contacting the appropriate District Office.

→ Form C-103, Miscellaneous Report, 3 copies must be filed within thirty days following the completion of plugging operations on any well. The report must contain a complete record of the work done. No plugging report will be approved until Form C-105 has been filed, and the location has been cleaned of junk, the pits filled, and the location levelled.

For information concerning forms to be filed in connection with the operation of producing wells, consult the book of general Rules and Regulations, or contact any representative of the Commission.
