On 12-1-80 CO₂ in Action (Rig #18) spudded a 12-1/4" hole at 6:00 p.m. Drilled to a TD of 701' and ran 8-5/8" set at 701'. Cemented with 450 SX Class C cement. Plugged down at 6:00 p.m. 12-2-80. Circulated 25 SX. WOC 24 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2650' and ran 5-1/2" casing set at 2647'. Cemented with 1100 SX Class C cement. Circulated 50 SX. Currently waiting on completion unit.
