Perforated 2160'-68', 86'-92', 2216'-21', 26'-34', 53'-60', 69'-72', 74'-76', 90'-92', 99'-2301', 16'-19', 30'-33' and 55'-59' with 1 JSPF. Ran packer and 3-1/2" tubing. Set packer at 592'. Fractured with 21000 gal 40#, x-linked gel with additives and 24000# 8/12 sand. Pulled tubing and packer. Cleaned out sand 2210'-2410' with sand pump. Ran 2-3/8" tubing and seating nipple. Tubing landed at 2094'. Moved out service unit 3-22-82. Turned well thru a separator and flow tested for 142 hrs. Well flowed 6739 MCF and 24 BLW. Ran 72 hrs. BHP Buildup test 3-27-82 thru 3-30-82. Well shut-in.
