Frac stimulated with 25,000 gal 40% gel and 73,800* 8/12 sand. Cleaned out sand. RITH with 1 ft. fiberglass tail pipe, coated packer, and 2 7/8" coated tubing. Set packer at 2000'. Flow tested through separator 5 days. Average flow 2148 MCFD. Returned well to production.
