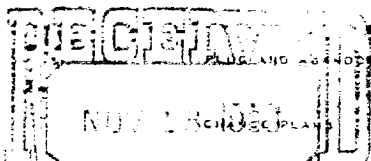

On 11-2-83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 1:15 pm. Drilled to 725' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Circulated 155 sacks to pit and plugged down at 8:30 am on 11-3-83. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing and set at 2958'. Cemented with 700 sacks class H and additives. Plugged down and circulated 89 sacks to pit. Tested casing at 1300 psi for 30 min and OK. Rig released 11-7-83 at 8:30 am. Currently waiting on completion unit.
