Propose to: MISU and Kill well w/ 2% KCL FW, Rel pkr and POH w/ tbg and pkr, RIH w/ 4" csy gun and perf 2440'-56' w/ 2 ISFF and 90° phasing. RIH w/ 1 jt FG tailpipe, pkr, and 3 1/2" tbg. Set pkr at 2210'. Pump annular volume of 2% KCL inhibited water down backside. Swab well to kick off flowing. Stimulate w/ 22 tons liquid CO2 as follows:
 1) Pump 6 tons as cool down, 2) Pump 12 tons dropping 3 balls / bbl (1.1 sg ball sealers), 3) Pump 4 tons liquid CO2 as flush. Flow test well for a period not to exceed 96 hrs.
 Return well to production.

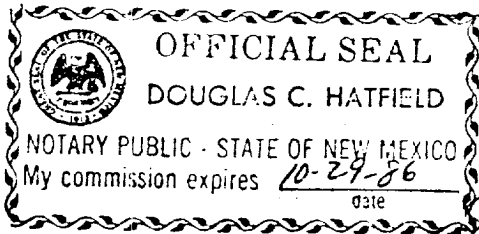
