DST 2774 Pkr at 2704. Open 1 hr. Air to Surface immediately and remained constant thru out tst. No O or G to surface.

Rec 570' sli G cut mud in drl pipe when pulled. No O.

5 min. SIBHP 210#.

DST 2803 pkr set at 2635. Open 1 hr. Air to surface immediately & continued thru out. NS O or G at Surface. Attempted btm hole pres. tst. No results as clock stopped while tools open. Rec 450' drlg mud in DP when pulled. NS O or G.

DST 2875 Pkr at 2808. Open 1 hr. Air to Surface immediately continuing thru out. NS O or G. 5 min SIBHP 1100#. Rec 1830' sli salty wtr & 450' very sli G cut mud in DP when pulled. NS O or G. Flwd some mud out of pipe when pulling.

DST 2920 Pkr 2872. Open 1 hr. Air to surface immediately & continued thru out. NS O or G. 5 min. Shut In Btm Hole Press. 1050#. Rec 100' sli slaty wtr & 270' G cut mud in DP when pulled. G in DP while pulling.

DST 3066 Pkr 3005. Open 1 hr. Air to surface immediately continuing thru out. 5 min SIBHP 1100#. Rec 120' sli G cut mud w/strong Sul wtr in DP. NS O. Flwd some wtr & mud when pulling pipe.

DST 3157 Pkr at 3125. Open 30 min. Air to surface immediately and gradually increased thru out tst. NS oil or Gas. Rec 180' Sli G cut mud and 1620' wtr w/odor of Sul in drl pipe when pulled.

PB 3514-2822. Ran 5 1/2" csg set & Cem at 2686. Drld plug. Bailed Rotary mud 1700-2200 w/fluid level constant last 20 hrs. Bailing at rate of 6 BPH. Fluid gradually changing mud to clear wtr. NS O or G. PB 2822-2800. Bailed mud & salt wtr 1400-2200 w/fluid level constant at 2200' while bailing 6 BPH.

DD 2800-2835. PB 2835-2795. Bailed 6 BPH at 2200'.

DD 2795-2805. P B 2805-2735. B ailed at 2200'. No change. 6 B PH.

NS O or G. PB 2735-2600. Pulled csg & abandoned well.
