IT IS THEREFORE ORDERED:

(1) That the applicants, Michael P. Grace II and Corinne Grace, are hereby authorized to complete their Humble-Grace Well No. 1, located 990 feet from the South line and 660 feet from the East line of Section 2, Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico, as a dual completion (conventional) to produce gas from the South Carlsbad Strawn and Morrow Gas Pools through parallel strings of 2 3/8-inch tubing with separation of zones by a packer set at approximately 11,110 feet or to produce gas from the Morrow formation through 2 3/8-inch tubing and gas from the Strawn formation through the casing-tubing annulus with separation of zones by a packer set at approximately 11,230 feet;

PROVIDED HOWEVER, that the above-described dual completion utilizing one string of tubing and the casing-tubing annulus shall be resorted to only if there is no danger of the Strawn zone being logged-off by liquids.

PROVIDED FURTHER, that the applicant shall complete, operate, and produce said well in accordance with the provisions of Rule 112-A of the Commission Rules and Regulations insofar as said rule is not inconsistent with this order;

PROVIDED FURTHER, that the applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Shut-in Pressure Test Period for the South Carlsbad-Morrow Gas Pool.

~~(1) That all mineral interests, whatever they may be, in the South Carlsbad-Strawn, South Carlsbad-Atoka, and South Carlsbad-Morrow Gas Pools underlying the N/2 of Section 2, Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico, are hereby pooled to form a 320-acre gas spacing unit and dedicated to a well to be drilled at an unorthodox location 2500 feet from the North line and 330 feet from the East line of said Section 2;~~

~~PROVIDED HOWEVER, that as to each of said pools, said well is assigned a ratable-take factor of 51%;~~

~~PROVIDED FURTHER, that in the event any of said pools be prorated, the subject well as to such prorated pool shall be assigned an acreage factor for proration purposes of 0.51.~~

(2) That all mineral interests, whatever they may be, in the South Carlsbad-Strawn, South Carlsbad-Atoka, and South Carlsbad-Morrow Gas Pools underlying the S/2 of Section 2, Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico, are hereby pooled to form a 320-acre gas spacing unit and dedicated to a well to be drilled at an unorthodox location 990 feet from the South line and 660 feet from the East line of said Section 2;

PROVIDED HOWEVER, that as to each of said pools, said well is assigned a ratable-take factor of 61%;

PROVIDED FURTHER, that in the event any of said pools be prorated, the subject well as to such prorated pool shall be assigned an acreage factor for proration purposes of 0.61.

(3) That Michael P. Grace and Corinne Grace are hereby designated the operators of the subject wells and units.
