

Mr. Johnson:

It has been a year since approval was given to perform remedial work and cleanup on this historical site near well 28. The weather, budget and equipment to perform this work has caused this delay.

Pure Resources has completed the excavation and hauling of the contaminated soil from the Pure 28 site as agreed in work plan and by the land owner, Mr. Darr Angell. A total of 38606 cu. yds. of soil was hauled to C & C Landfarm and Saunders Landfarm. The analytical for the site does meet the criteria for closing as OCD guidelines require. A PID was used to conduct headspace test for BTEX and final sampling was below 10 ppm. Find within photos, analytical and manifest for this site.

Pure would like to start backfilling the excavated area with clean soil, hauled from the rancher, Darr Angell. After we finish backfilling, leveling and seeding, a final report will be sent to the OCD.
