

Describe Cause of Problem and Remedial Action Taken.*

DCP Midstream's V-3-7-2 8-inch steel sweet gas pipeline was reported to have a blowing leak. DCP's construction crew was dispatched to depressurize and repair the line.

Describe Area Affected and Cleanup Action Taken.*

An estimated six bbls of condensate leaked from the line and impacted a 30' x 50' area on private land. DCP excavated impacted soils to a depth of three feet and stockpiled it on plastic sheeting. A composite sample was obtained from the excavated area and analyzed for BTEX and TPH. BTEX and TPH values must be below BTEX, TPH cleanup criteria prescribed in *Guidelines for Remediation of Leaks, Spills, and Releases (1993)* authored by the New Mexico Oil Conservation Division and is a function of groundwater depth and distance to water wells and surface water bodies. The depth to groundwater is understood to be >100 feet, there are no known domestic water wells within 200 feet, and no water bodies within 1000 feet. Results were within cleanup levels (Benzene <10 ppm, BTEX <50 ppm, TPH <5000 ppm) and the area backfilled with clean soil.


