27BBLS of PW and 10 BBLS oil was released due to leaking gasket on fire tube flange on heater treater. 0BBLS were recovered. Released fluid flowed in a Southeastern direction. The approximate total area affected on pad was 30ft by 24ft. The approximate total area affected off pad was 84ft by 24ft on the Southeast side. An environmental company will be contacted for remediation.
