As per our conversation yesterday, April 4, 2017, when COG has a release on a well pad or tank battery operations will take immediate actions to address the release. Operations will go remove impacted soil before HSE has the site sampled, in some cases they are successful in the removal of all impacted soil. In the case of the spill release site referenced above, analytical results demonstrate that initial response actions taken by our operations group were sufficient in the remediation of this release. COG is respectfully requesting review of the attached closure report (originally submitted January 23, 2017) and closure approval from the NMOCD. Also attached for your records, BLM Closure Approval.
