Dr. Oberding and I have conferred about the workplan for 1-RP4455. The workplan would be approved with these conditions. Please confirm.

- 1) Approved: only the area surrounding the battery (SP 4 & 5) can be excavated to 3 ft. bgs and backfilled with clean material before placement of a liner.
- 2) Denied: A gypsum liner is not suitable.
- 3) Vertically delineate SP2 and 3 until chloride levels of 250 mg/kg is reached + 10 ft. bgs. A combination of OSE and Chevron trend map suggest depth to GW < 100 ft.
- 4) Horizontal delineation: add one more sample location between SP2 and SP3.
