Please also mark the dimensions of the Lucid pipeline and provide GPS coordinates of the confirmation sample locations.

- 1. Is the March 19, 2017 date written on page 3, a mistake? The release did not occur until March 21, 2017.
- 2. Where was the source of the soil used to backfill the pipelines for Lucid Energy? Please provide field data for the testing of these soil samples.
- 3. What is the extent and dimensions of the proposed 4 ft. excavation and liner? Please include a scaled map of the excavated area outlined, location of the properly keyed liner, and confirmation sidewall and bottom sample locations demarcated.
- 4. Sidewall samples are required at the edge of the impacted area to complete horizontal delineation and release characterization. Lateral distance between confirmation samples locations should be no greater than 50 ft. apart.
- 5. Provide all field data along with laboratory analyses.
- 6. Soil bore logs must be included.
