Confirmation soil samples collected at the A-14 Compressor Station Below Ground Sump Release Site will be collected approximately every 40 feet, which will be in the vicinity of the delineation soil samples collected during the sampling event on March 22-23, 2017 and correspond to the delineation soil samples numerically (S-1 = BH-1). The depths of the confirmation soil samples will be determined during excavation activities, but are anticipated to be as follows: BH-1 @ 6", BH-2 @ 6", BH-3 @ 21", BH-4 @ 21", BH-5 @ 6", and BH-6 @ 6", and BH-7 @ 6".
