NMOCD will consider delineation as complete for 1RP-4728.

However, as mentioned in the email dated September 19, 2017, regarding remedial activities:

- 1. Tilling is not acceptable for the area represented by SP6 9. Surface TPH levels exceed permissible concentrations at SP6 and SP7, and perhaps SP8 and SP9 as well since MRO levels were not provided. NMOCD requires a minimum of 6-inch removal for the area represented by SP6 SP9.
- 2. Confirmation sample locations at 1.5 ft. bgs in the area represented by SP3 SP5 needs to be marked on an appropriately scaled map in the remediation report.
- 3. One confirmation sidewall sample location must be at the border between the proposed 2 ft. excavation (pink) and the area with no remediation (blue).

NMOCD still requires data indicating that the release has been characterized for 1RP-4728.

- 1. Based on the provided data, the implication is the area represented by SP3-SP5 did not have any pooling locations with a southwesterly slope. Correct assumption? Provide photo documentation as evidence.
- 2. NMOCD will agree to tilling of the area represented by SP6-8. However, since the surface samples for SP6 and SP7 were above permissible TPH values, discrete confirmatory samples in the approximate locations at 6 inches are required before and after tilling. Laboratory analyses for TPH extended (GRO, DRO, MRO) using Method 8015.
- 3. NMOCD will agree to the proposed 2 ft. excavation for the area represented by SP1-SP2. Laboratory analyses for chlorides (Method 300) and TPH extended (GRO, DRO, MRO) using Method 8015.
- 4. Confirmation samples are required for the edges of the areas represented by SP1-SP2, SP3-SP5, and SP6-SP8 to complete release characterization. Sample locations cannot be greater than 50 ft. apart.
- 5. Provide a scaled map with the sample locations for confirmatory edges, sidewalls, and bottoms marked.
