- The battery is located on Fee surface. NMSLO can confirm.
- Based on the release location, the average depth to groundwater is 49 ft., not 69 ft.

NMOCD will consider the delineation as completed for 1RP-4650. The proposed remediation is not accepted.

- Permissible TPH levels are 100 mg/kg. The proposed excavation must be 3 ft.
- Laboratory analyses of confirmation sidewall and bottom samples must demonstrate permissible limits for BTEX, TPH extended (GRO, DRO, MRO), and chlorides.
- Establish sidewall and bottom sample locations <= 50 ft. apart.
- In the remediation report, include an appropriately scaled map with the confirmation sample locations marked with GPS coordinates and the depth of excavation annotated.
