3/14/2018 Mover in equipment. Cleared location and rigged up. Laid down 73-3/4" rods. Installed BOP. POOH with tubing. Laid down tubing due to poor condition. SION

3/15/2018 RIH with workstring to 1852'. Attempted to load the hole with brine. Would not load. Mixed 50 sx cement with CaCl and drilling paper and spotted at 1852'. WOC and tagged cement at 1704'. POOH to 552' and attempted to load the hole again. Still would not load. Spotted 50 sx cement with CaCl and paper at 552'. POOH and SION.

3/16/2018 Tagged cement at 542'. Established circulation with 22 bbls. No fluid to the pit. All coming from around the wellhead. Circulated cement to surface from 542'. Caught returns with a vacuum truck. Took 145 sx to get good cement tot surface. Laid down remaining pipe and rigged down. Dug out and cut off wellhead. Filled to surface and installed marker. Cut off anchors and cleaned the pit.
