DESIGN PLAN FOR CLOSED-LOOP SYSTEM

Heritage Resources, Inc. has filed for a permit to plug back the Pawnee Deep Unit #1 well and use the following closed-loop system to contain and dispose of any fluids which may be produced during this operation:

A 250 bbl steel flow back pit will be set on the location and will capture any fluids produced during flow back. If the fluids are produced water, this water will be disposed of at the facility of DC Energy, permit #240A.

A 500 bbl test tank will be set on location to capture any crude oil or condensate produced during testing. Any produced oil or condensate will be sold to Plains Marketing, LP.
