08-04-05 Pressure tested casing to 1000psi for 30 minutes.

08-08-05 In 12-1/4" hole, ran 82jts 9-5/8" 40# J-55 LTC casing to 3505'. Cemented with lead 20bbls spacer + 960sx Interfill C + 1/4# Flocele and tail 200sx Premium Plus + 1% CaCl2. Circulated 171sx to pit. WOC 20.5 hours.

08-09-05 Pressure tested casing to 1000psi for 1.5 hours.
