2. Dump bail 35' cement Class H cement on CIBP or spot 25 sack minimum
3. Spot 273' plug (Class H) from 12873'-12600', WOC and tag @ 12600'
4. Spot 210' plug (Class H) from 11000'-10890' (Wolfcamp)
5. Spot 180' plug (Class H) from 7840'-7660' (Bone Spring)
6. Spot 400' plug (Class C) from 5200'-4600' (DVT, Delaware, and shoe), WOC and tag @ 4600'
7. Spot 130' plug (Class C) from 3000'-2870' (Yates/BOS), WOC and tag @ 2870'
8. Spot 100' plug (Class C) from 1135'-1035' (Shoe), WOC and tag @ 1035'
9. Spot 100' plug (Class C) from 100'-surface
10. At cut-off verify cement to surface on the backside of the 5-1/2" and 8-5/8" casings. If not remedial cement will be required to bring cement to surface.
