NEED TO REPAIR STUFFING BOX, REMOVE CONTAMINATED SOILS AND FLUIDS FROM CELLAR AND AREA AROUND WELLHEAD. PIPE ALL BRADENHEADS TO SURFACE AND FILL IN CELLAR WITH CLEAN MATERIAL. 1st notice.

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.

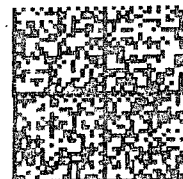
