A review of our longer term plans for this field indicate that it would be beneficial to drill and complete this well as an injection well. This Sundry Notice of Intent requests approval to drill the well as an injection well.

Appropriate Applications for Authorization to Inject are being sought. No injection will occur until regulatory approvals are in place.

This well is expected to spud March 2013.
