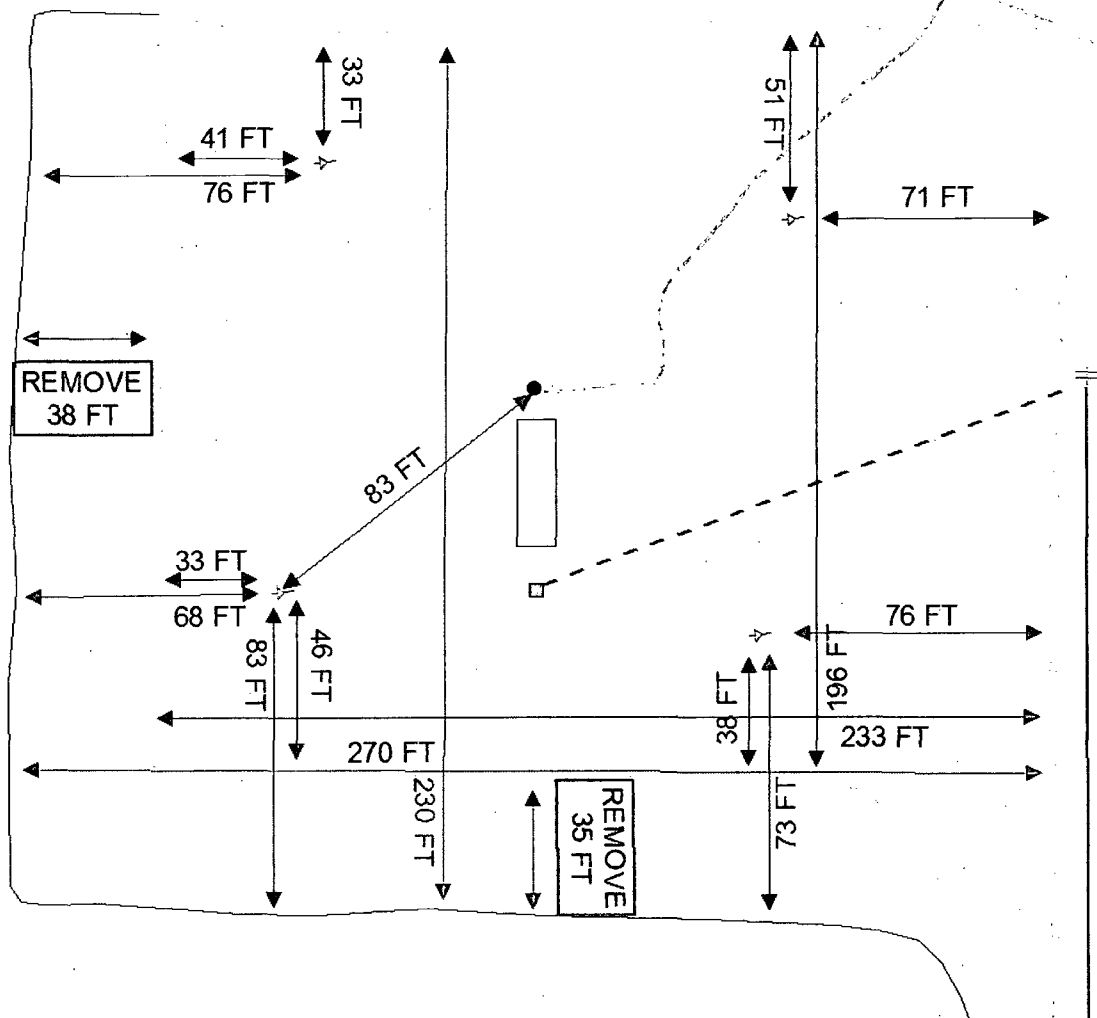

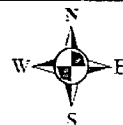
The original pad measured 230 FT x 270 FT
