Mr. Michael Novy:

Please consider this letter as notification, informing Novy Oil & Gas Inc. of compliance violations regarding the well referenced above.

On April 4, 2013, the NMOCD District I Office performed a visual inspection of your well noted above. As a result, the well is out of compliance and the violations are clearly defined and justified below. It is at your best interest that you review the violations noted below and contact our office within the time noted above.

It is imperative that you communicate with the District I office and discuss the intentions and efforts to bring this well back into compliance.

*If the OCD District I Supervisor does not hear from you by April 22, 2013, the OCD will commence the process to justify an application for hearing. This hearing will be in regards to the wells out of compliance and in reference to 19.15.25.8 NMAC. This process could lead and allow the OCD to plug the well and forfeit any financial assurance if Novy Oil & Gas Inc. does not comply with NMOCD's request.*

• Last Date of Production 10/2010; Operator Submitted NOI C103 to Perform Remedial Work, Approved 1/2011.  
As of April 2013, NOVY OIL & GAS has made no attempt to work on this well, or inform the NMOCD of potential changes or future use of well.


**VIOLATION 5/8/2007:**

***Direct Violation of NMOCD Rule 19.15.16.8 "Sign on Wells"***


