Dear Operator:

Rule 19.15.5.9 NMAC provides that the listing of a well on the Oil Conservation Division's (OCD's) inactive well list as a well inactive for more than one year plus 90 days creates a rebuttable presumption that the well is out of compliance with 19.15.25.8 NMAC (the inactive well rule).

An operator may rebut that presumption by providing evidence that the well is in compliance with 19.15.25.8 NMAC.

Endurance Resources, LLC (Endurance) currently has multiple wells appearing on the OCD's inactive well list as wells inactive for more than one year plus 90 days. However, Endurance recently has working with the BLM and the OCD to bring these wells back into compliance.

OCD is in the process of entering into an Agreed Compliance Order (ACOI) with Endurance and will be coding the extension expiration dates for these wells into the system so that the wells will not appear on the inactive well list for purposes of Rule 19.15.5.9 NMAC.

Endurance has rebutted the presumption created by Rule 19.15.5.9 as to some of the wells on the current list. Attached to this letter is a current inactive well list for Endurance, copies of sundries already submitted to the BLM requesting approval for five (5) of those wells to be brought back onto production, an e-mail response from Jim Amos of the BLM indicating approval to plug two other wells on the IWL and the processing of a third well to be put back on production, and a list of the nine wells that Endurance has submitted Sundry Notices. If all the sundries are approved, Endurance's IWL will be reduced to ten (10) wells.

Although these wells still appear on the inactive well list, the OCD should not consider them as out of compliance with 19.15.25.8 NMAC or include them in calculating Endurances' compliance with Rule 19.15.5.9 until the approved ACOI has been entered into and expires.
