Operator needs to remove fencing, cattleguard, brace and piping on NE corner to the point where it goes below ground level (leave valve or bull plug line), and ladder on east side against fence. Operator should also contact power provider to request removal of transformers. A copy of this correspondence will need to be provided to this office prior to release.


