Tail w/200 sks Class C w/2% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Plug down @ 3:00 AM 01/12/15. Circ 150 sks of cement to pit. WOC. At 12:15 P.M. 01/13/15, tested csg & BOPE to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
