

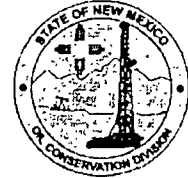

An unorthodox location is required due to a combination of geology and geophysics. The target location is in a non-standard location.


