Yates Petroleum Corporation plans to plug and abandon this well as follows:

1. MIRU all safety equipment as needed. NU BOP. TOH with production equipment. Make a GR/JB run down to 11,296'. Set a 5-1/2" CIBP at 11,286' then dump 35' Class "H" cement on top of CIBP. **CIRC MLF.**
2. Spot a 80 sx Class "H" cement plug from 10,266'-9770', this will cover top of Canyon an top of Bough C.
3. Spot a 30 sx Class "H" cement plug from 9018'-8828', this will cover top of Wolfcamp.
4. Spot a 30 sx Class "H" cement plug from 7743'-7573', this will cover top of Abo.
5. Perforate 5-1/2" casing at 5464'. Circulate a 60 sx Class "C" cement plug from 5464'-5314' inside and outside 5-1/2" casing, this will cover top of Glorieta. **WOC & TAG**
6. Perforate 5-1/2" casing at 4191'. Circulate a 60 sx Class "C" cement plug from 4191'-4041' inside and outside 5-1/2" casing, this will cover 8-5/8" casing shoe. **WOC & TAG**
7. Tag plug covering 8-5/8" casing shoe and perforate 5-1/2" casing at 450'. Circulate a 185 sx Class "C" cement plug from 450' up to surface.
8. Cut off wellhead, install dry hole marker and clean location.

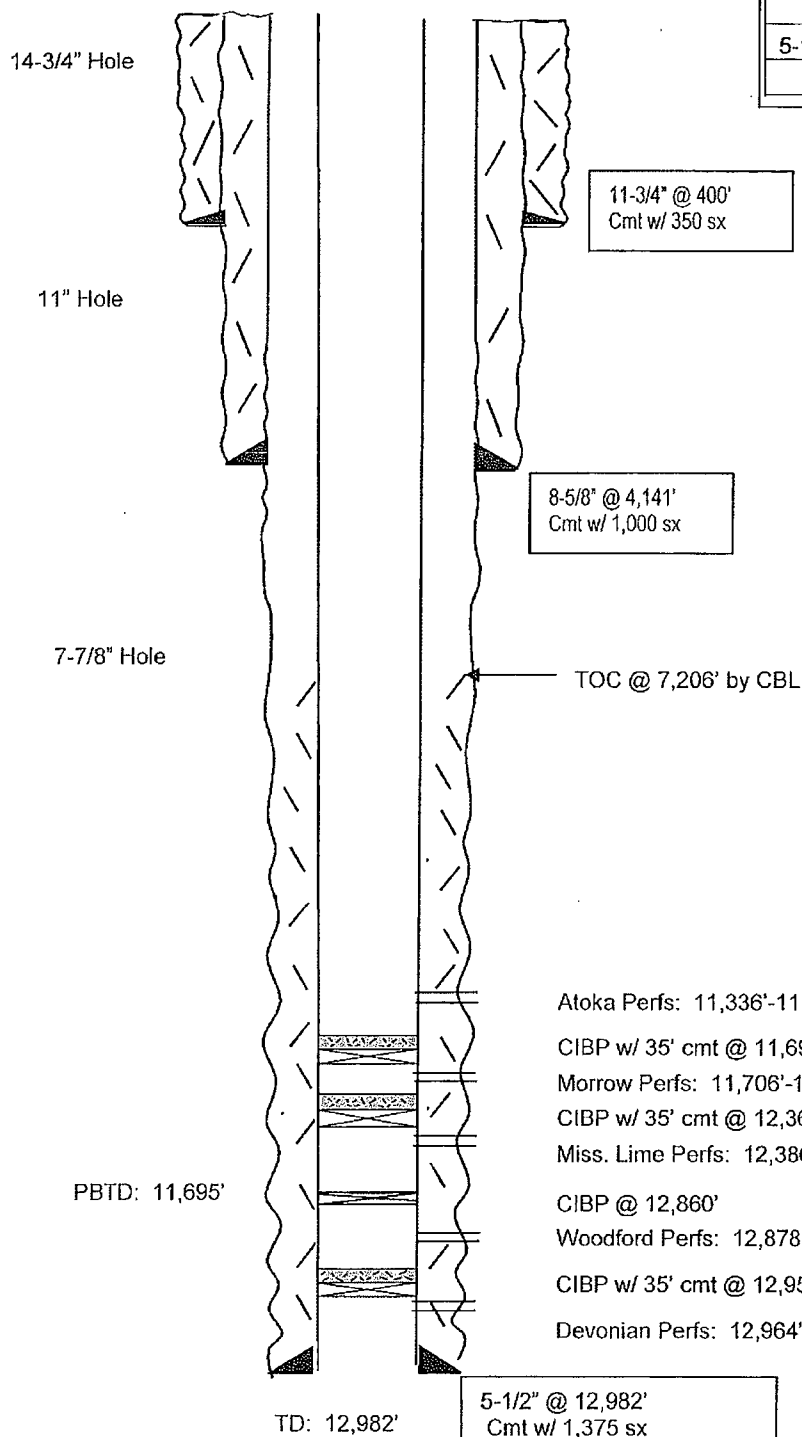

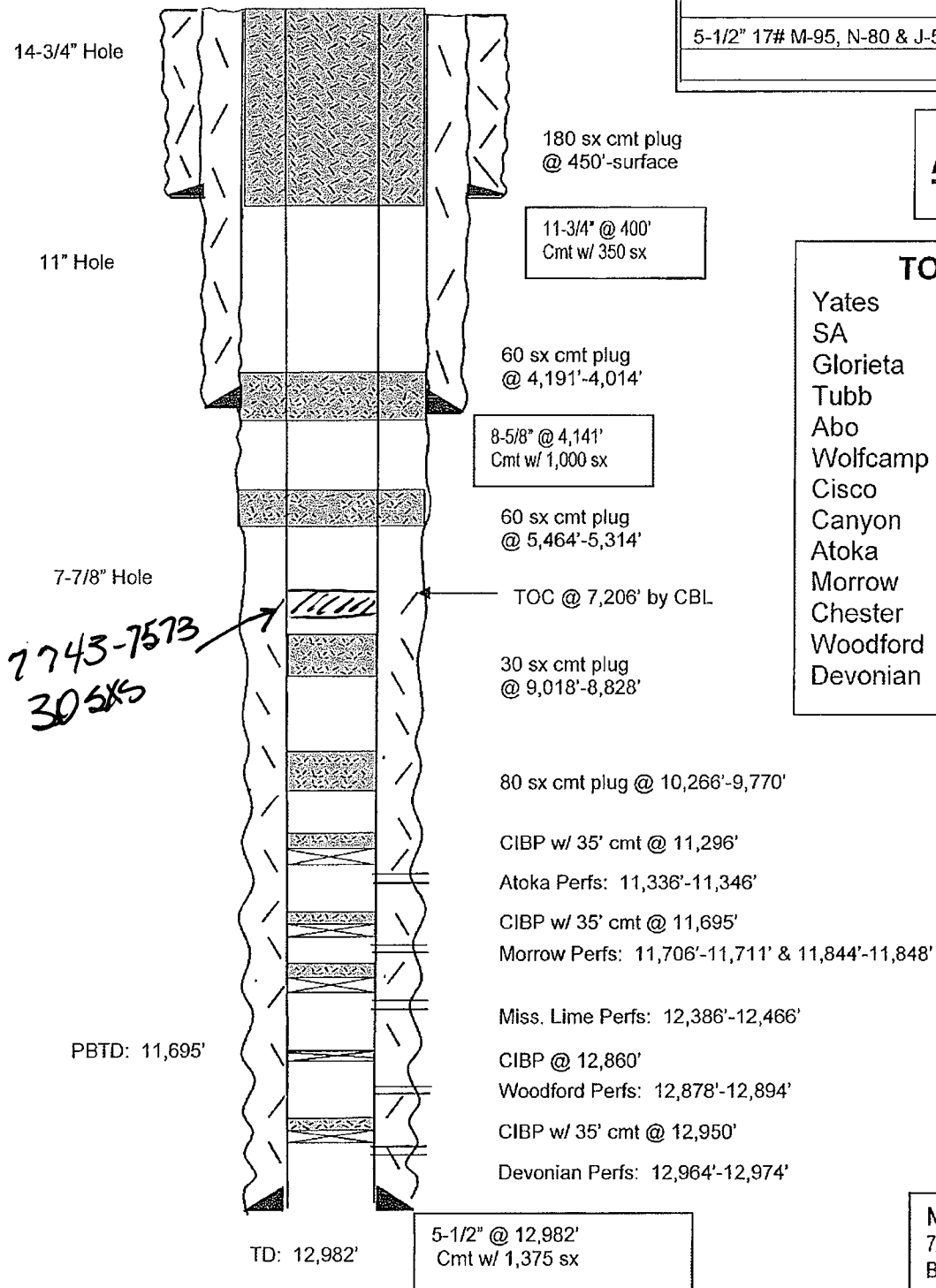
