

Per the APD and the COA (p.12 of 17), minimum working pressure on the Blowout Preventer (BOP) and related equipment (BOPE) required for drilling below the surface casing shoe shall be 5000 (5M) psi.

Legacy Reserves respectfully requests to use a 3000 (3M) BOPE to drill from the surface casing shoe (~1800') to the intermediate casing shoe (~5400'). The BOP will be a 5M system, however the "A" section wellhead will be a 3M wellhead. Given that the surface casing (13-3/8" 54.5#, J-55, STC) burst is rated at 2730 psi, the 3M wellhead for this section of the well is sufficient.

Below the intermediate casing shoe, a 5M BOPE will be used.
