Records searches were conducted on November 4, 2014, for the proposed SD WE 23 Fed P5 #1H, SD WE 23 Fed P5 #2H, SD WE 14 Fed P5 #1H and SD WE 14 Fed P5 #2H well pad in Township 26 South (T26S), Range 32 East (R32E), Sections 14 and 23. All wells will be on a single pad.

Sources consulted included Bureau of Land Management Carlsbad Field Office (BLM/CFO) GIS database and the online GIS database maintained by the New Mexico Historic Preservation Division, Archaeological Resource Management Section, in Santa Fe, NM. These records indicate archaeological survey coverage of the project area (NMCRIS #s: 63533, 126220, and 130167). No archaeological sites have been found in the project area and only one site has been previously recorded within a <sup>1</sup>/<sub>4</sub>-mile radius.

In consultation with BLM archaeologist Stacy Galassini, it was determined that no additional survey is required. The project is recommended for approval without further archaeological survey as currently staked. A copy of this letter will be forwarded to the BLM Carlsbad archaeologist.


