09/29/15 RIH and tag cement at 4658'. Witnessed by BLM. POOH. Rig up casing jacks and pull on 5-1/2" casing. Run freepoint. Determined casing free at 2700'. Cut casing at 2700'. POOH w/ 5-1/2" casing.

09/30/15 Pumped 50 sx Class C cement plug at 2750'.

10/01/15 RIH and tag cement at 2534'. Pull up hole to 1575'. Spot 30 sx Class C cement plug at 1575'. WOC 4 hrs. RIH and tag cement at 1331'.
