9/16/2015 RU Par Five. Spotted a 50sx Class H plug @ 9280. POH with tubing. RIH tagged cement @ 8896'. Spot 35sx Class C plug @ 7616'.

9/17/2015 RIH and tagged plug @ 7510'. Talked to Patricia Hutchinson with BLM and got the approval to set a CIBP @ 7490' w/35' cement cap.

9/21/2015 RIH tag @ 7347', spoke to Patricia with BLM she gave approval to set CIBP on top of cement.

9/22/2015 Set CIBP @7315'. Pressure test casing to 1500#, Tested good. Chart is attached.
