11/17/15 Vacuum trucks arrived on site and removed the liquids from the two (2) 500 bbl tanks.
11/18/15 Vacuum truck steamed and cleaned both of the tanks. The catwalk and landing were removed. Backhoe arrived on location and started building the west, south and north fire walls. Also removed all the T-posts and corners.
11/19/15 Laid out 48 x 70 feet of liner on location and secured in place. Backhoe made new tank pad and leveled. Crew loaded fiberglass tanks and set them on the pad and leveled. Installed catwalk and landing. Backhoe finished the firewall and also dug the holes for the corner posts.
11/20/15 Installed the load line on the tanks and made door gaskets. Installed and plumbed in the fill line and dump line. Cemented in the corner posts and built the fence. The backhoe finished the firewall and pushed up the old location.
11/24/15 Dug out a 30 x 100 feet spill area. Removed the contaminated soil 4 feet below ground level. The contaminated soil was hauled to Gandy Marley Land Farm in Roswell, New Mexico.
