Environmental Problem No.1: By previous email, we are proceeding with removal of the road that NM Dept of Fish and Game has been using for the past 18 years.

Environmental Problem No.2: We will attempt to remove risers, but they are still part of the active gathering system. The concrete pad will be removed regardless.

Environmental Problem No.3: As we have only now been advised to take up the road, naturally the report for the post reclamation seeding has not been submitted. After the seeding has been completed, we will then submit a subsequent report.

Environmental Problem No.4: A Final Abandonment Notice was filed in June, 1994 (attached). A second FAN will be submitted after road is restored.
