## DESCRIPTION

A strip of land 30 feet wide, being 2,350.83 feet or 142.475 rods in length, lying in Section 9, Township 21 South, Range 37 East, N. M. P. M., Lea County, New Mexico, being 15 feet left and 15 feet right of the following described survey of a centerline across the lands of the Millard Deck Estate Trust:

Thence N 88'39'44" E, 243.00 feet, to Engr. Sta. 22+88.80, a P. 1. of 77'23'50" right;




