04/05/16 Ran MIT, pressure casing to 543#, held. Well is now TA'd.

Legacy's future plans on this well will involve the performance of a wellbore cleanout and acid stimulation throughout the perforated Blinberry interval 5361'-5478'. Also, we may re-perforate the previously perforated and currently cement squeezed Upper Blinberry interval 5149'-5333' during this cleanout operation. We plan to do this work in the 1st quarter of 2017, pending improved oil prices.

We were unsuccessful in cleaning this well out on 01/16/2015 using coiled tubing and subsequently attempted to make a simple bit run cleanout on tubing on 04/01/2015. From this work we realized a more extensive cleanout procedure will be required and we TA'd this well on 04/02/2015 by setting a CIBP at 5082' using wireline and capping with 35' of cement using wireline dump bailer.
