Plugging Report Ricky "A" State #1

9/29/2016 Roaded rig and equipment to location. Located anchors and spotted rig.

10/3/2016 Rigged up and laid down rods and pump. Dug out wellhead and installed BOP. POOH with tubing and tallied. Made scrapper run and set CIBP at 1755'. Circulated MLF and tested casing to 500 psi. Spotted 25 sx Class C on top of CIBP. POOH and SION.

10/4/2016 RIH and tagged cement at 1429'. Perforated 4 ½" casing at 1070' and squeezed with 35 sx Class C with CaCl. WOC and tagged cement at 904'. Perforated 4 ½" casing at 349'. Pumped cement down 4 ½" casing to perfs at 349' and up 8 5/8" casing to surface. Took 100 sx Class C cement. Rigged down and cut off wellhead. Cement had fallen from surface. Filled up both strings with 10 sx cement. Observed for 30 minutes. Cement remained at surface. Installed Marker and cut off anchors.
