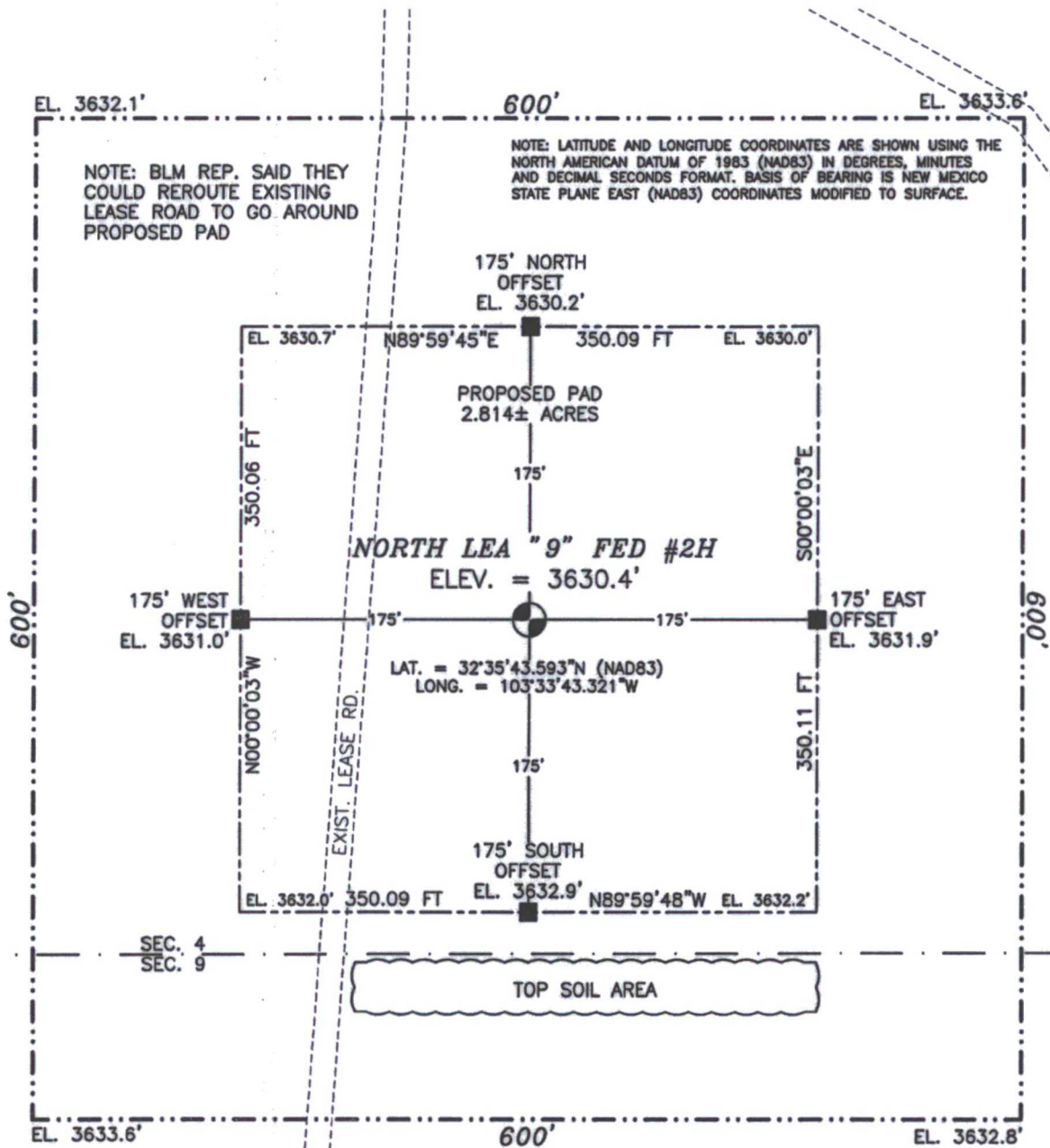

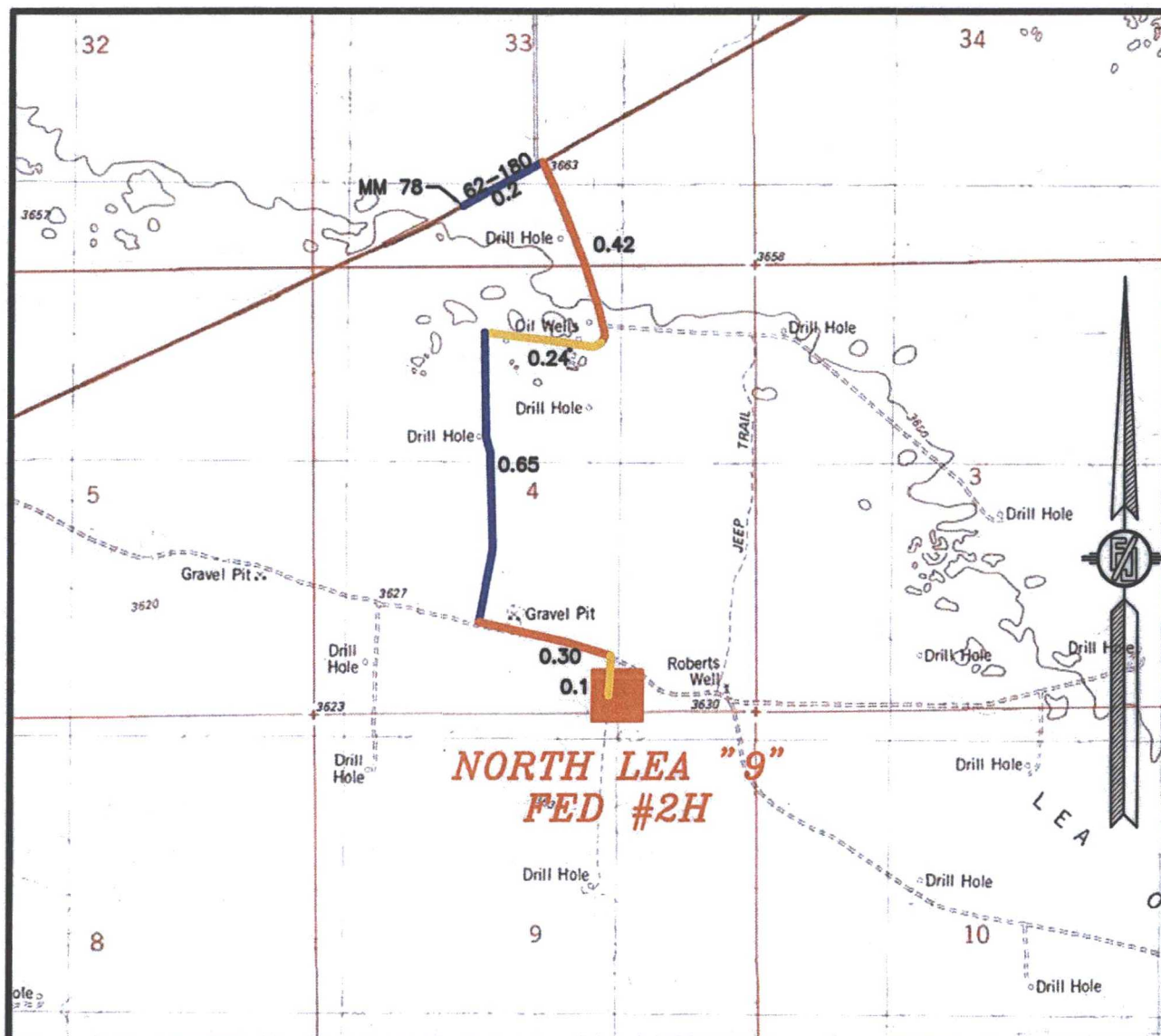

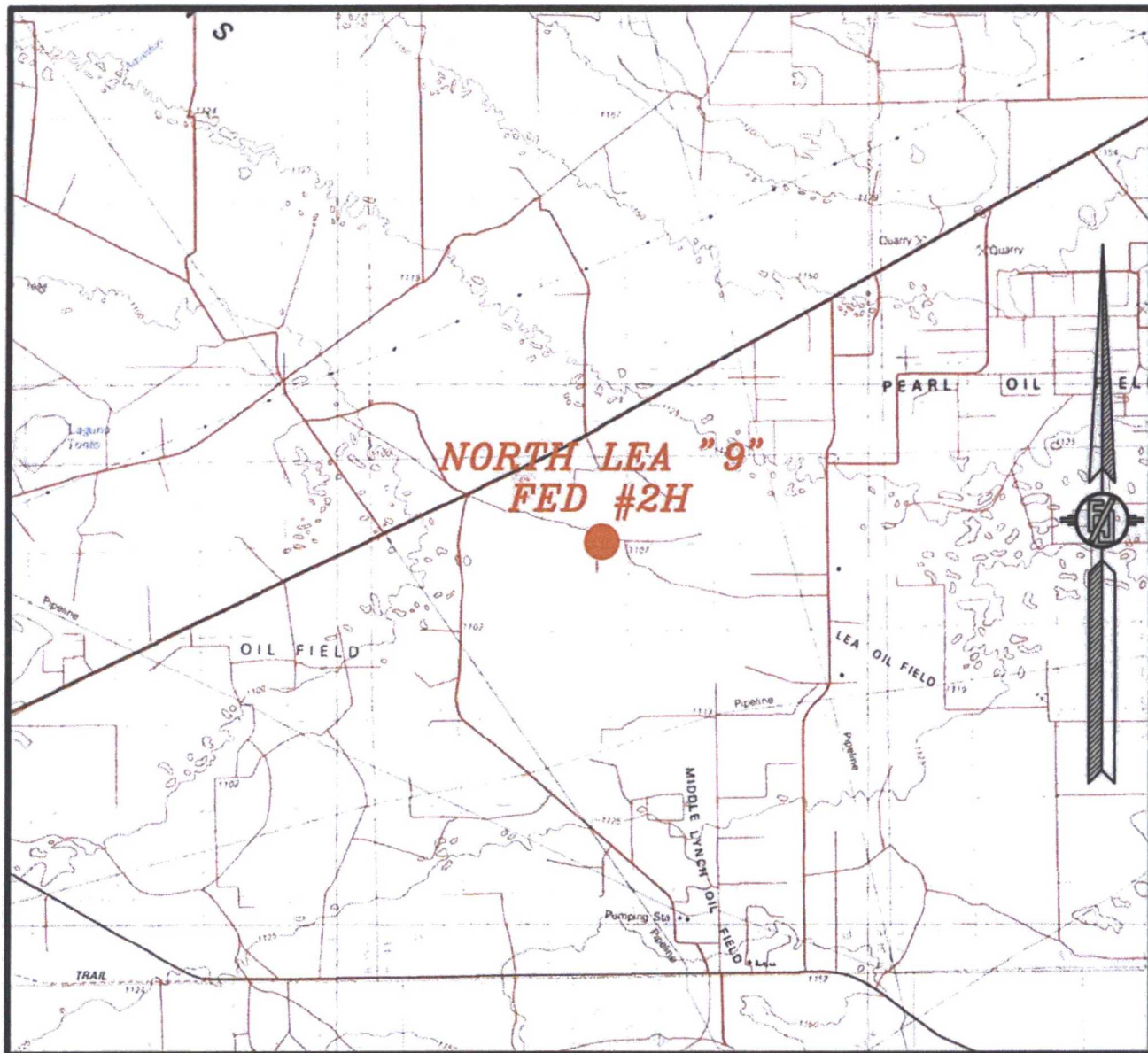

VICINITY MAP



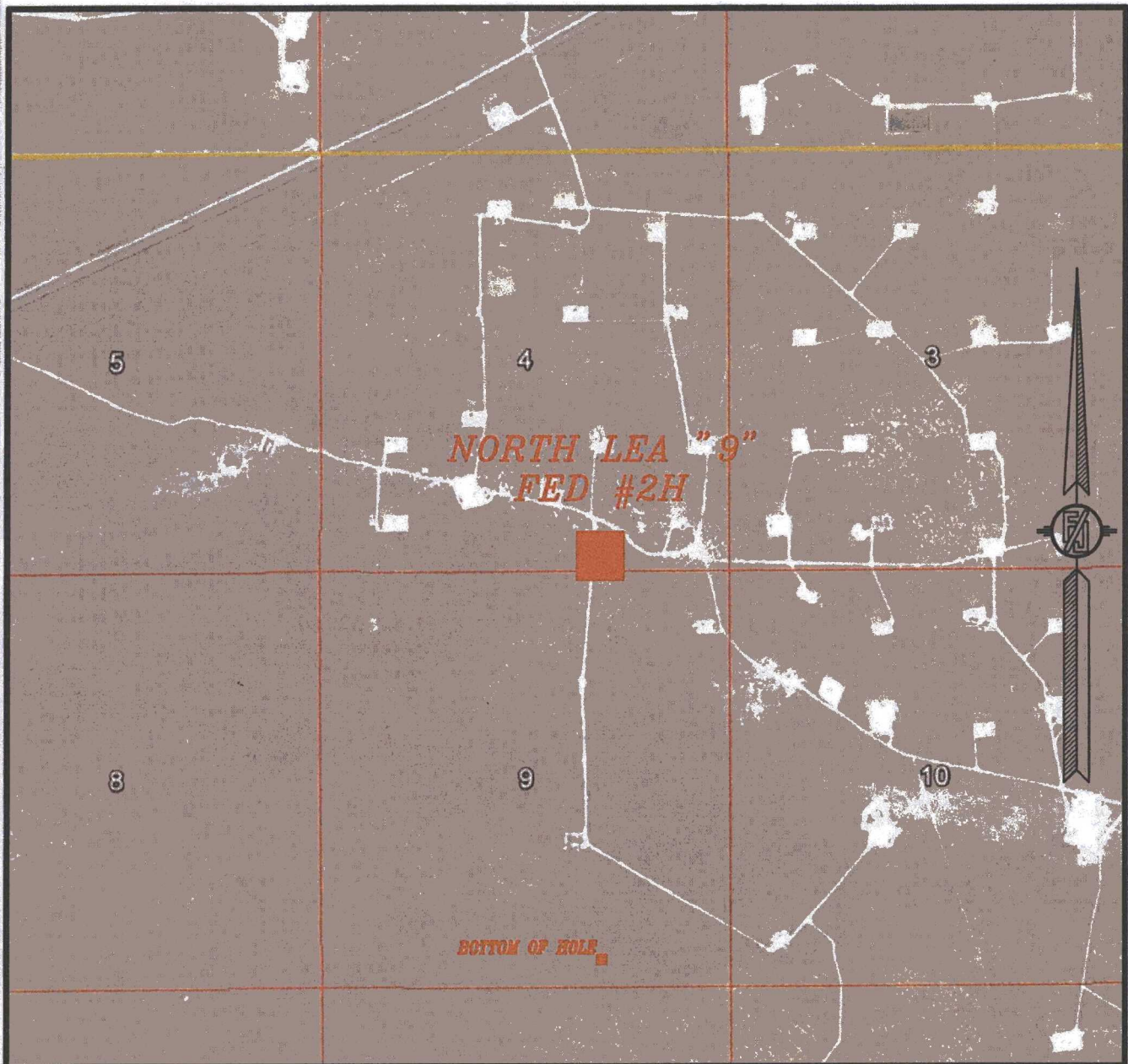

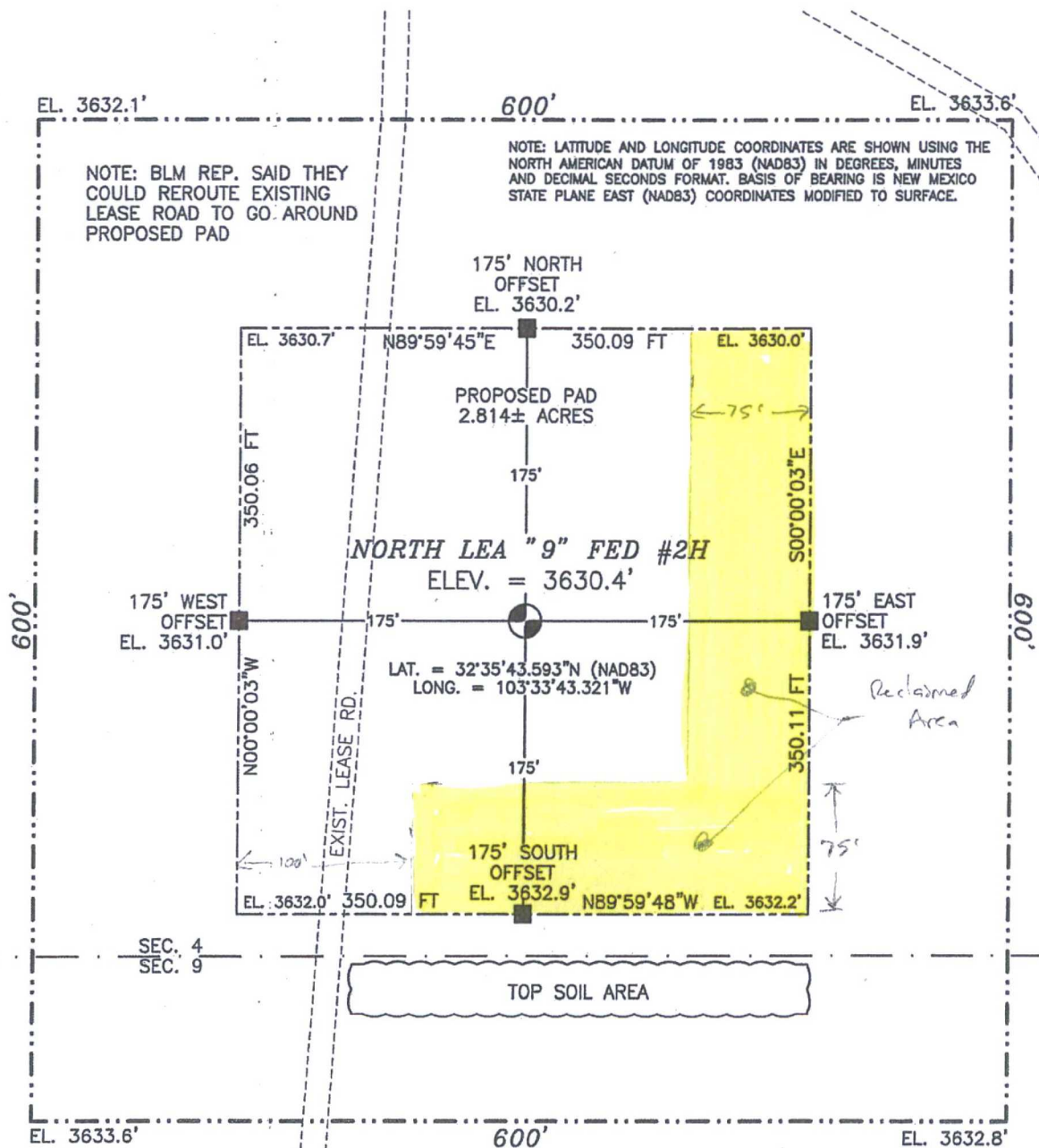
